B. SETH BAILEY

SENIOR DIPLOMATIC FELLOW

B. Seth Bailey joined the Daniel K. Inouye Asia-Pacific Center for Security Studies (DKIAPCSS) in July 2022 as the Department of State's Senior Diplomatic Fellow. Prior to joining APCSS, Mr. Bailey served as the Minister Counselor for Political Affairs at U.S. Embassy Beijing from 2019-2022. From 2015-2017, Mr. Bailey was the Acting Deputy Director of the State Department's China Desk. He served as the Co-Chair of the Economic Bureau's China Task Force where he also worked on the Trans-Pacific Partnership. From 2011-2013, Mr. Bailey led public affairs and public diplomacy programming in Northeast China at U.S. Consulate Shenyang. Mr. Bailey has also served as the Acting Deputy Political Counselor in Kabul, Afghanistan from 2017-2018 and the Department's Senior Advisor for South Asia in the Bureau of Counterterrorism. Prior to joining the State Department, Mr. Bailey practiced law in Pacific Northwest and Mountain West. He received a Juris Doctorate from the University of Texas School of Law and a Bachelor of Arts from Brigham Young University. He speaks Chinese, Korean, and Tamil.

MICHAEL C. BURGOYNE

PROFESSOR

Mr. Michael Burgoyne joined the faculty at the Daniel K. Inouye Asia-Pacific Center for Security Studies in July 2016 as a U.S. Army Military Professor. He arrived from the American Institute in Taiwan (AIT) in Taipei, where he served as the Army Programs Officer in the Security Cooperation Office. As a Foreign Area Officer (FAO) specializing in China and Taiwan, Mr. Burgoyne studied and worked in Beijing before assignments in Washington, D.C. and Taipei, Taiwan. He co-edited *China's Global Influence: Perspectives and Recommendations*, which is a cross-regional, cross-functional examination of the actions and intentions of the People's Republic of China. Mr. Burgoyne has a BA in Finance from Tulane University in New Orleans, and a MA in East Asian Studies from Harvard.

CARLETON R. CRAMER

CAPTAIN, U.S. NAVY (Ret)

DEAN, COLLEGE OF SECURITY STUDIES

Carleton R. Cramer joined the Daniel K. Inouye Asia-Pacific Center for Security Studies (DKI APCSS) in 2004 as a military faculty member. In 2007, Mr. Cramer retired from the Judge Advocate General's Corps, United States Navy. During 2007-13 he served as a civilian faculty member focusing on international law, counterterrorism and maritime security. In August 2013, he assumed his current position as Dean of the College of Security Studies. Mr. Cramer completed his Bachelor of Arts degree in 1979 at the University of California, Santa Barbara, with majors in history and political science and a minor in economics. In 1982, he earned his Juris Doctor at the University of the Pacific, McGeorge School of Law. In 1983, he graduated from the Naval Justice School and in 1993, he earned his Masters of Law from The Judge Advocate General's School, Charlottesville, Virginia. Mr. Cramer grew up on Kwajalein Atoll, Republic of the Marshall Islands. His twenty-

seven-year naval career includes numerous assignments in the Asia Pacific region, including two command tours. Additional experience in the region includes working for the Supreme Court of Hawaii and for the U.S. Attorney, District of Hawaii. Mr. Cramer is a member of both the California and Hawaii State Bars. He is admitted to practice before the U.S. Supreme Court, the U.S. Court of Appeals for the Armed Forces, U.S. Court of Appeals for the 9th Circuit and the U.S. District Court, District of Hawaii.

LUKAS FILLER, Ph.D.

COMMANDER U.S. Navy (Ret.)

PROFESSOR

Lukas Filler has led and conducted research as well as advised USG senior leaders on the strategic logic and implications of PRC decisions and behavior with the China Strategic Focus Group at US Indo-Pacific Command, Center for Strategic and International Studies (CSIS), US Air Force Culture and Language Center, the Applied Research Lab for Intelligence & Security at the University of Maryland, the Office of the Deputy Chief of Naval Operations (OPNAV N3/N5), Naval Special Warfare Command, Joint Special Operations Command, Office of Naval Intelligence, US Naval War College, the Center for Naval Analyses (CNA), and Vannevar Labs. A graduate of Bowdoin College, Lukas studied comparative morality in foreign policy decision making, strategic preferences, and the use of force – with a focus on China – for a Masters of Theological Studies at Harvard Divinity School, as a Harvard University Sheldon Fellow in China and Taiwan, as a two-time Senior Visiting Scholar at Renmin University of China, and for a PhD from King’s College London Department of War Studies. Lukas started his professional career a Naval Aviator, flying P-3C Orion and other aircraft in Iraq, Afghanistan, Africa, and other locations, earning 4 Combat Air Medals as well as other decorations.

LORI A. FORMAN, Ph.D.

DEVELOPMENT ADVISOR and PROFESSOR

Lori Forman joined the Daniel K. Inouye Asia-Pacific Center for Security Studies in 2011, bringing a unique international background in corporate, government, academic, and non-profit sectors. An expert on international economic development and foreign aid, civil society and public-private partnerships, Dr. Forman earned a Ph.D. from the Faculty of Law, Keio University, and a Master in Public Policy from Harvard University. Prior to joining APCSS Lori held senior corporate positions with Microsoft and Dubai Holding. In government, she held senior positions including the U.S. Alternate Executive Director on the Board of Directors of the Asian Development Bank and Assistant Administrator for Asia and Near East of the US Agency for International Development. Dr. Forman also served in the NGO sector for 11 years, as the Director of the Japan Program of The Nature Conservancy, one of the world’s largest environmental organizations. Dr. Forman began her post-graduate career in Washington D.C., serving as the Senior Political Analyst for the White House pollster.

PETER A. GUMATAOTAO
REAR ADMIRAL, USN (RET)
DIRECTOR

Pete Gumataotao became the Director, Daniel K. Inouye Asia-Pacific Center for Security Studies (DKI APCSS) in February 2018. A native of Guam, RADM (Ret) Gumataotao joined the Navy in 1976 and attended the Naval Academy Preparatory School in Newport, Rhode Island. He is a 1981 graduate of the United States Naval Academy and earned his Master of Arts in Strategic Studies from the U.S. Naval War College in 1994. Pete has extensive experience operating in the Asia-Pacific region during 37 years of active duty service, including eight years as a U.S. Navy flag officer. In addition to undertaking eleven deployments conducting defense and security exercises, he served in executive-level, strategic management capacities, notably as Commander, U.S. Naval Forces Korea for U.S. Pacific Fleet (CNFK), and Current Operations Director for both U.S. Pacific Fleet (PACFLT) and U.S. Pacific Command (PACOM). His U.S. Naval decorations include the Defense Distinguished Service Medal, Defense Superior Service Medal, Legion of Merit (five awards), Meritorious Service Medal (four awards), and other personal, unit, and campaign awards.

DR. SCOTT HAROLD
SENIOR ADVISOR
DEPUTY ASSISTANT SECRETARY OF DEFENSE (EAST ASIA)

Dr. Scott W. Harold is currently Senior Advisor, Deputy Assistant Secretary of Defense (East Asia) within the Office of the Undersecretary of Defense for Policy's Office of Indo-Pacific Security Affairs, where he works on U.S. –Australia Alliance issues as well as coordinating IPSA equities with the Daniel K. Inouye –Asia –Pacific Center for Security Studies. Prior to this, he was a Senior Political Scientist at The RAND Corporation from 2008 –2023, including four years as the Associate Director of RAND's Center for Asia-Pacific Policy. He has also served as an Adjunct Professor of Security Studies at Georgetown University (2006 –2023), an Adjunct Professor of International Affairs at Columbia University (2017 –2023), and an Adjunct Professor of International Affairs at The George Washington University (2019 –2020). Lieutenant Colonel Jacqueline L. Hearne joined the Daniel K. Inouye Asia-Pacific Center for Security Studies (DKI APCSS) in July 2022 as a military faculty member. LTC Hearne completed her Bachelor of Arts degree in 2002 at Furman University with majors in political science and philosophy. In 2012, she graduated from the Defense Language Institute Foreign Language Center with an Associate of Arts degree in Japanese Language. In 2015, she earned her Master of Arts in Regional Studies: East Asia from Columbia University in the City of New York. LTC Hearne began her Army career as an Aviation Officer and C-12 pilot conducting signals and imagery intelligence missions utilizing both manned and unmanned platforms. In 2011, LTC Hearne became a Northeast Asia-focused Foreign Area Officer and subsequently served in various positions across the Indo-Pacific, including United States Army- Japan liaison officer to the Japan Ground Self-Defense Force Western Army Headquarters in Kumamoto, Japan; Japan Country Director at U.S. Indo-Pacific Command, Camp Smith, Hawaii; and Assistant Army Attaché at the U.S. Embassy in Tokyo, Japan. ALEXANDRA B. LANGLEY

CHIEF OF STRATEGY AND ASSESSMENTS

Alexandra Langley serves as the Chief of Strategy and Assessments at the Daniel K. Inouye Asia Pacific Center for Security Studies (DKI APCSS) and is responsible for the Center's strategy; plans development; policy alignment; and assessment, monitoring, and evaluation efforts. She is a career civil servant with significant experience in international relations, foreign policy, and interagency collaboration in the Indo-Asia-Pacific region. Prior to DKI APCSS, Ms. Langley worked at U.S. Indo-Pacific Command and served in key positions within the Directorate for Strategic Planning and Policy (J5) including Deputy Division Chief for Southeast Asia Policy, Branch Chief for China/Taiwan/Mongolia Policy, China Director, and Taiwan Director. PROFESSOR

Dr. Srinu Sitaraman joined the Daniel K. Inouye Center for Asia Pacific Studies as a Professor in December 2019. His focus is on Indo-Pacific security with a particular focus on South Asia, Regional Conflict, & India-China Relations. His research also focuses on New Technologies & International Security, Internet and Digital Diplomacy, Nonproliferation, Maritime Issues, and the United Nations and International Law. Sitaraman holds a Master's Degree in International Affairs from Ohio University and received his Doctorate in Political Science and International Relations from the University of Illinois Urbana-Champaign. Prior to arriving at the DKIAPCSS, Sitaraman was a tenured Associate Professor in the Department of Political Science at Clark University in Worcester, MA. He was also a core member faculty for the Asian Studies Program, adjunct faculty in the Strassler Center for Holocaust and Genocide Studies at Clark University, and an Associate-in-Research at the Fairbank Center for Chinese Studies at Harvard University.
