Bush Administration Conceptions of the Aid

National Security Council:

- LAF as a counterweight to Hezbollah
- A strong LAF could undermine Hezbollah's raison d'être
- A capable LAF could constrain Hezbollah activity



Department of Defense:

- LAF as a domestic CT force targeting SUNNI terrorists
- A positive model of functioning, non-sectarian "state" institution
- Role in border security and public order

• 2020: \$216 million in FMF, IMET & DOD authorized funding



 - Concerns about intel sharing



8- دعم المقاومة باعتبارها حقاً مشروعاً للبنانيين حتى زوال الاحتلال ونتائجه:

تقر المواثيق واعلانات الحقوق الدولية لجميع الشعوب حقها في مقاومة الاحتلال والعدوان والدفاع عن النفس بكل الوسائل والامكانيات التي تتيح لها البقاء.

. وفي هذا السياق تعتبر مقاومة اللبنانيين للاحتلال الاسرائيلي في الاراضي اللبنانية المحتلة, حقاً مشروعاً الى ان يتم زوال الاحتلال.

وقد ادت هذه المقاومة التي لقيت دعماً من الدولة والجيش والمواطنين الى اندحار العدو مهزوماً من معظم الاراضي اللبنانية. غير ان العدو ما يزال متمركزاً في مواقع لها اهمية كبرى استراتيجياً واقتصادياً لذلك فإن من حق اللبنانيين مقاومته حتى انسحابه من مزارع شبعا.

Collusion with Hezbollah

• Examples:

- 2007 Hezbollah land-to-sea missile/LAF naval radars
- 2008 Hezbollah invasion of West Beirut
- 2013 Raid on Sheikh al Assir in Sidon
- 2017 155mm artillery support of Hezbollah ground operations in Arsal
 - Reportedly also Armed Caravan (Hellfires) and M142 HIMARS

Other ongoing examples:

- Operating jointly manned checkpoints
- Continuing de-confliction with Hezbollah along eastern border
- Prosecuting critics with military tribunals
- Obstructing UNIFIL operations in Southern Lebanon
 - Removing hardware from launch sites prior to investigation
