## Australia: Mr. David Nockels

Mr. Nockels is the First Assistant Secretary, Defense Industry Policy in the Australian Department of Defense, and is responsible for Defense Export Controls, Defense Industry Policy, and Defense Industry Domestic Policy. The Division is responsible for the effective implementation of the Government's approach to Defense industry policy and the creation of a strategy-led program of industry engagement and innovation.

Mr. Nockels previously held the role of First Assistant Secretary of People Policy and Culture. In this role, he was responsible for People Policy & Employment Conditions, Defense Learning, and Culture & People Development.

Mr. Nockels holds an Executive MBA from the Australian Graduate School of Management, University of New South Wales, a Master's Degree in Security Policy Studies from the George Washington University in the USA, and a Bachelor of Arts Degree from the Australian National University in Canberra, Australia.

#### Australia: Ms. Alison Petchell

Ms. Petchell has over 15 years of experience delivering technology to the Australian Defense Force across all stages of the capability life cycle. In her current role in the Capability Acquisition and Sustainment Group, she oversees delivery cooperation with a wide range of international partners. She is responsible for ensuring international procurement practice supports speed to capability. From 2019 until 2021, Ms. Petchell was the Minister Counsellor of Defense Materiel at the Embassy of Australia in Washington DC, where she worked with local Security Cooperation Agencies to establish business cases, manage delivery risks, facilitate export licenses, and ensure timely transport of equipment.
